

Hunt Fair Chase Contest Rules 10-15-2018:

Please read Official Rules before entering the Hunt Fair Chase Contest (the Contest), sponsored by the Boone and Crockett Club (Sponsor). By entering the Contest, you agree to be bound by Official Rules and represent that you satisfy all of the eligibility requirements below.

No Purchase Necessary to Enter or Win. A purchase will not increase your chances of winning.

- 1. Eligibility.** Contest is open only to legal residents of the 50 United States who currently reside in the US and who are 18 years of age or older at the time of entry. ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS APPLY. To be eligible to win a prize, entries must be completed and received by Boone and Crockett Club in the manner and format described. Directors, officers and employees of Sponsor and any of their respective parent companies, affiliate companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and immediate families of each are not eligible to win any prizes. **Limit one entry per person.** Any person found to be using multiple entries will be disqualified. The prize winner for the Contest will be determined by selection from all eligible entries. The winner will be notified via Boone and Crockett Club Facebook Page and website (huntfairchase.com) within 30 days of the end of the promotion period. Option #2: Email a maximum of 450 words or up to 3 minutes video on *“What Fair Chase Means to You”* to info@huntfairchase.com. Email entries must be received by 11:59 PM (MST) on December 31, 2018.

Option #3: Send via U.S. Postal service or other a maximum of 450 words printed or 3 minutes of video on a USB stick or DVD to Boone and Crockett Club detailing *“What Fair Chase Means to You”* to; Hunt Fair Chase Contest, 250 Station Drive, Missoula, MT 59801. Mail-in entries must be postmarked by 11:59 PM (MST) on December 31, 2018 and received by 7 days thereafter.

By submitting your entry, you are acknowledging and agreeing that Sponsor has the right to stream your video or post your essay through Facebook or other online platforms, and or

publish your entry in Boone and Crockett Club print and electronic publications.
